RESOLUTION NO. 01 12-30 SERIES 2024

A RESOLUTION ADOPTING AND, IN SOME CASES, INCREASING THE OPERATING FEE SCHEDULE AND SEPTIC WASTE FEES

WHEREAS, the Leadville Sanitation District ("District") is a quasi-municipal corporation and political subdivision of the State of Colorado and a duly organized and existing special district pursuant to law; and

WHEREAS, the District Board of Directors ("Board") has the authority to fix and, from time to time, increase or decrease fees, rates and charges, pursuant to law for services, programs or facilities furnished by the District; and

WHEREAS, the Board hereby finds and determines that it is in the best interest of the public health, welfare and safety of the District residents and visitors that the District collect adequate revenues to pay ongoing operation, maintenance, and capital improvement costs; and

WHEREAS, the Board has considered the most recent rate analysis performed by District staff and finds the recommendations contained therein comply with the laws related to rational nexus and reasonable proportionality for the establishment of rates, fees, tolls and charges; and

WHEREAS, notice of the Board's intent to consider rate increases at the December 30, 2024 special meeting was provided to the District's customers more than thirty (30) days in advance in accordance with law.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Leadville Sanitation District that:

Section 1. The rates, fees, and charges set forth below are hereby adopted to be effective as of January 1, 2025:
